

## Re-entry of foreign nationals who possess status of residence in Japan

The holders of the valid status of residence with valid re-entry permit who left Japan on or before 26th May 2020 are now allowed to re-enter Japan. (Due to COVID-19, India was designated as an area subject to denial of permission to enter Japan on 27th May, 2020)

### 1. What will be required to re-enter Japan?

To re-enter Japan, following two documents need to be presented upon arrival at the airport in Japan;

1) **Letter of Confirmation for Re-entry in to Japan** (hereinafter referred to as “Re-entry Confirmation Letter”) which can be obtained from the Embassy/Consulate General of Japan where

applicants resides

2) **Certificate of Negative COVID-19 test result** conducted within 72 hours of the departure time of the flight

### 2. Special conditions for Re-entry Permission

1) The above process is **not** required for those who possess the valid Re-entry Permit of either of the **four categories** of “Permanent Resident”, “Spouse or Child of Japanese National”, “Spouse or Child of Permanent Resident” or “Long Term Resident”, if they re-enter into Japan **in August 2020**. It is also not required for those who already received **earlier approval confirmation** email

received from the Embassy/Consulate General of Japan if they re-enter into Japan in August 2020.

2) Please note that “Re-entry Confirmation Letter” as well as Certificate of Negative COVID-19 test result will also be required for those who possess the valid Re-entry Permission holders including above four categories to re-enter into Japan **on or after 1st September 2020**.

### 3. How to apply for “Re-entry Confirmation Letter”?

1) To apply for “Re-entry Confirmation Letter”, the applicant is required to visit Consular Section of the Embassy/Consulate General of Japan to submit application and necessary documents. (Please note; some of the Embassy/Consulates General request advance

reservation to visit Consular Section.)

2) Following documents are required to be presented for the application. (Application Fee: No charge)

- Valid Passport with valid re-entry permit including special re- Valid entry permit
- Residence card issued by the Japanese authority
- Application Form with all the necessary description

3) It will take a few days to process the application (Please note that “Re-entry Confirmation Letter” is not issued on the same day of application). The applicant will be contacted once “Re-entry Confirmation Letter” is ready or in case their application is denied. The applicant (or a representative of the applicant) can obtain “Re-entry Confirmation Letter” at Consular section of the Embassy/Consulate General of Japan where they applied at designated time/date.

4) Please note that issued “Re-entry Confirmation Letter” is valid only during the time of your valid passport with valid re-entry permit.

4. Contact details of Consulate General of Japan in Mumbai.

5. For those who left Japan on or after 27th May 2020

The applicants who have **departed Japan on or after 27th May 2020** need to contact the Embassy of India in Tokyo, Japan to inquire the procedure to re-enter Japan.
